Three Volunteers to be Recognized for Lifetimes of Volunteer Service in Boulder County

Boulder County (May 2, 2011) – The Community Foundation announced today that Thurston “Ted” Manning will receive the 2011 Stan Black Award and Norm and Carol Cail will be honored with the Pat on the Back Award.

Stan Black Award (photo below)

The Stan Black Award honors an individual who, like Stan Black, has given a lifetime of “time, treasure and talent” to Boulder County non-profit organizations. Stan Black is one of The Community Foundation’s founders, and when he retired from his law firm, Hutchinson, Black, and Cook, LLC (HBC), the firm decided to honor Stan by establishing the award at the Foundation. HBC continues to sponsor the annual award and participate in the selection process.

Ted Manning was nominated by Kathy Pollicita of Frasier Meadows Retirement Community and chosen by a committee of community members to receive this year’s award, because of his extensive volunteer leadership with organizations such as Special Transit, Frasier Meadows Retirement Community, Boulder Bach Festival, CU’s College of Music, Colorado Music Festival, Boulder Rotary, CU’s School of Education, and more.

Current Boulder Rotary Club President, Michael Weatherwax, stated in Ted’s nomination packet: “Ted is our Renaissance man, our go-to guy, the wittiest, wisest, and most community-minded member whose example the other 259 BRC members can only aspire to emulate.”

Pat on the Back Award (photo below)

The **Pat on the Back Award** is named to honor Pat Shoemaker and to recognize other individuals who have given extraordinary, but often unsung volunteer time in caring for the community. A “pink lady” volunteer for the Boulder Community Hospital for 28 years, Pat also produced monthly original craft displays for the hospital. Pat was the Boulder Community Hospital Outstanding Volunteer of the Year in 1983 and was honored as the Colorado Auxilian of the year in 1984. She was a homemaker and the mother of two daughters, Linda Shoemaker of Boulder and Judi Miller of Tucson, Arizona.

Norm and Carol Cail have dependably led and grown the Friends of the Longmont Library Book Sale and Board of Directors since the mid-1970’s. Their nominator James England commented about Norm and Carol’s attention to detail, calming affect on other volunteers, wisdom about how to grow the sale, and what a huge gift their joint dedication has been to the whole community. With Norm and Carol’s help, the Friends of the Longmont Library Book Sale now handles more than 200,000 books per year and has annual revenues of \$70,000.
