All of the above are funds within The Community Foundation Serving Boulder County except the Foothills Flood Relief Fund at Foothills United Way.

- The Lyons Community Foundation granted \$1 million to individuals just before Christmas—an accomplishment made possible by the money donated through The Community Foundation and grants from other sources such as the Foothills Flood Relief Fund at Foothills United Way.
- Coming Community Foundation Flood Relief Grants:

\$128,889 more will be granted through the Front Range Farm Relief Fund and the Greater Jamestown Community Fund before Summer 2014.

Over \$530,000 is earmarked for long-term recovery needs. \$500,000 will support Lyons and Jamestown, through their respective Rebuild Lyons and Rebuild Jamestown funds in the following areas:

## Do you Know?

- The most common request from individual disaster-relief applicants was for the replacement of household items—everything from appliances to bedding to clothing, because many people's homes were completely washed away or damaged by water or a mudslide. FEMA and insurance don't usually cover these types of day-to-day items.
- Over 200 washers and dryers still need to be replaced in homes impacted by the floods.
- Of the \$32,621,426 in total recovery costs for the households surveyed by the Long Term Flood Recovery Group of Boulder County, \$17,668,207 is from uninsured households.
