Privacy Policy

The Community Foundation Serving Boulder County (“Community Foundation”) recognizes and respects the privacy of donors and website users. This policy describes the types of information we may collect from you or that you may provide when you visit our websites <http://www.commfound.org/>, <http://readyssetlearn-early.org/>, <http://opendoorfund.org/>, <http://efcolorado.org/>, <http://www.pledge1percent.org/> (collectively “Websites”) and our practices for collecting, using, maintaining, protecting and disclosing that information.

This policy only applies to the information the Community Foundation collects on our Websites. It does not apply to information collected by us offline or by any other means, nor does this policy apply to any information collected by any third party, including through any application or content that may link to or be accessible from or on our Websites. Your browsing and interaction on any other website, including websites to which the Community Foundation links, is subject to that website’s own rules and policies. Please review those policies and rules before proceeding as the Community Foundation does not make any representations about the policies of any organization or website to which we link and disclaims any liability or responsibility for such other website’s content, rules or policies.

Types of Information We Collect

The Community Foundation collects two types of information on our Websites: (1) personal information you knowingly and voluntarily provide that is collected on an individual basis, and (2) website use information collected automatically, and on an aggregate basis, as you and others navigate through our Websites.

Personal Information You Provide to Us. The information we collect on or through our Websites may include information that you provide by submitting forms on our Websites or making a donation to the Community Foundation via the Websites. This includes information provided online at the time of making an online donation. . The Community Foundation does not store or keep on file any of the financial information provided.

Website Use Information. The Community Foundation uses cookies on this website. Cookies can enable us to track and target the interests of our users to enhance the experience on our site. As you navigate through and interact with our Websites, we may automatically collect certain information about your computer hardware and software. This information can include: your IP address, browser type, domain names, access times and referring website addresses. .

How We Use Your Information

We may use information that we collect about you or that you voluntarily provide to us to present our Websites and its contents to you, to provide you with the services that you requested, to send you email confirmations for your online donation, and to notify you about any Community Foundation events or other information related to the Community Foundation’s mission. If you wish to opt-out or unsubscribe from any Community Foundation services, please contact us through email, telephone or U.S. Mail as provided below.

Information Disclosure

The Community Foundation does not rent, sell or share any personal information about individual users with any third party except to provide the services you have requested. The Community Foundation may

disclose your personal information to comply with any court order, law or legal process, including to respond to any government or regulatory request.

Credit Card

If you choose to make an online donation on our Websites, you will need to accept the terms in addition to providing personal information including name, mailing address, billing address, telephone number, credit card number, credit card expiration date and a CCV. Information is collected through a third party for which the Community Foundation provides a direct link.

Security

We have implemented measures designed to secure your personal information from unauthorized use, alteration and disclosure.

Your Consent

By accessing or using our Websites, you consent to the collection and use of information by the Community Foundation as outlined in our privacy policy. This policy may change from time to time. Updates to the policy will be posted on this privacy policy page. Continued use of our Website after we make changes is deemed to be acceptance of those changes.
